- b. Continue to deliver the Kingston Making Safeguarding Personal pilot (Year 2).
- c. Continue support for the London Safeguarding Adults Board, Safeguarding VOICES and Conference Planning Groups (Year 3) to ensure people with lived experience of safeguarding are integral to safeguarding systems and processes across London.

Healthwatch Kingston Road Show 2021
Our Healthwatch Kingston Road Show across Kingston's seven libraries (pop-up community
engagement sessions) was being planned for Oct/Nov, but these have since been postponed
until the beginning of 2022. With new Covid guidelines being introduced in response to the
Omicron variant we will keep the scheduling of these under review. The aim is to ask local
people what they think Healthwatch Kingston should prioritise for 2022/23 but we will explore
how this engagement can be done differently if face-to-face isn't deemed safe.
Living with Long Covid?
Healthwatch Kingston and other SWL HW organisations are working with the NHS in South West
London to gain insight into people's experiences of Long Covid, to help improve the support
and services that are available.
SWL Healthwatch organisation leads met at the beginning of December and agreed to use our
six local area research to inform a SWL Long Covid Experiences report. The timeline for this is
to meet in late January to to piece together a final report with infographics. In the meantime,

Residents, family, and friends' experiences of residential care during the
coronavirus pandemic
Between January to March 2021, Healthwatch Kingston ran two surveys about the experiences
of residents, and family members and friends of residents of Care Homes, Supported Living Homes and Extra Care Housing during the pandemic. Anonymised raw data has been collated
and shared with key Kingston Carers Strategy Group leads to help inform the new strategy. Data
is being internally analysed and themes identified for reporting. HWK have agreed to share the

Bereavement support and services - community engagement
Healthwatch Kingston is working collaboratively with Kingston Voluntary Action to deliver this
engagement with the South West London Bereavement Think Tank (which includes us working
with the Revd Susan van Beveren, Head of Chaplaincy, Pastoral & Spiritual Support Services).
The Covid-19 pandemic put a spotlight on end of life care and bereavement support and during the first wave of the pandemic NHS South West London Clinical Commissioning Group (CCG) set up an end of life care response group and a working group focused on bereavement support for residents in south west London. It was agreed to pilot the development of a framework to help engage with residents in the borough affected by bereavement and understand the support needs for people.
The aim of our partnership community engagement is to better understand the needs of people who are affected by bereavement. The public survey is designed to be inclusive of all kinds of loss; for example, expected or sudden deaths, miscarriages or death of children and young people. It is relevant to anyone affected by a bereavement or supporting someone through grief - before and during the pandemic (inclusive of deaths related to and not related to Covid-19). <u>Click here to complete the Kingston partnership survey about bereavement support and services within our community.</u>
There are a series of community focus groups being planned and we will augment this with two additional professional provider and community stakeholder surveys due out imminently. The deadline for responses to all survey's will be the end of January 2022, with initial high-level

BAME Mental Health Partnership Meeting - RBK We attended the BAME Mental Health Partnership relaunch meeting that took place on 5 Oct 2021.
It was an interactive meeting with breakout rooms giving partners a chance to share ideas and discuss priorities and issues. Healthwatch Kingston will be working closely with this group going forward.
SWLStG community transformation with Kingston VCSE
The adult community mental health transformation programme moved into its next phase in Kingston. SWLStG are putting together a proposal for the use of the funding over the next year. They will submit this proposal for approval in mid-January, prior to final submission to NHSE/I at the end of the month.
SWLStG have been working with stakeholders across the borough to shape their approach. Two meetings were arranged for those who haven't previously been involved to share their thoughts, which Healthwatch Kingston were asked to help promote. One was cancelled due to staff sickness. KC requested that another be held as some people couldn't make the second date. SWLStG were unable to arrange this, however colleagues will be attending the Mental Health and Wellbeing subgroup on 21 December to update.
 The proposal guidance sets out specific areas for consideration, there were 3 key questions: How will we adopt integrated or other partnership approaches to workforce planning with local authorities and the VCSE that result in integrated service delivery?

Support young people to have a say in their health and care services	The joint podcast made with the Kingston and Richmond Youth Council (KRYC) on Young People's Mental Health during the Covid-19 pandemic is very nearly ready to be released. It has been an epic journey to get this done as the recording was so long. HJW, Alex Quinnell from KRYC and one of our young people had many meetings to get this edited. It is still with the KRYC Communications Team but will hopefully be ready to promote before Christmas. Although it has been great to work together with KRYC, the lesson learnt here is collaboration takes much longer!
		As previously explained, Kingston Carers' Strategy is being refreshed to make sure everyone works together to recognise the enormous contribution of Kingston's carers, of all ages, and to find the best way to provide the support they need. The strategy is being created in partnership with young and adult carers, Kingston Council, Kingston Carers' Network, health partners in South West London Clinical Commissioning Group and other voluntary sector organisations. YOL! helped to shape the young people's survey and to promote it via their channels. The closing date for the Young Carers' Survey was 17th December 2021.
		Sadly, due to the ongoing threat of Covid, it was deemed necessary to cancel our face-to-face YOL!/KRYC joint Christmas Party at Heatham House which was planned for Monday 13 December. We hope to re-schedule in early next year when it is safer.
		HJW is currently running YOL! on her own after Giulia from HW Richmond left at the end of October. HW Richmond are still looking to replace her.

LSAB Conference Planning/Involvement
SB and HJW are part of the conference planning team, and we met weekly along with Tristan Brice (LondonADASS), Alvin Kinch (HWE) and Liz Symmonds (Met Police). The LSAB Conference ran virtually (via Zoom) on Tuesday 16 November and was during Safeguarding Adults Week 2021 which took place between 15 - 21 November 2021. The Conference Day itself did not run as planned due to technical issues with internet access etc. Several of the break-out sessions were not able to run on the day, so they were set up as a series of standalone luncheons running the following week.
The feedback from the conference has been very positive and it has already been decided to run a similar plan for the LSAB Conference 2022. It was also agreed that the voice of the PwLE of safeguarding is key, so there will be much greater involvement/co-production with the LSVG for next year.
